### PUNOLJETNI POČINIOCI KRIVIČNIH DJELA U BOSNI I HERCEGOVINI

*ADULT PERPETRATORS OF CRIMINAL OFFENCES  
IN BOSNIA AND HERZEGOVINA*

2018.

Cilj statističkog istraživanja jesu pokazatelji o punoljetnim prijavljenim, optuženim i osuđenim počinjnicima krivičnih djela, koji su važan instrument za proučavanje strukture kriminaliteta i odluka tijela krivičnog postupka.

*The goal of statistical survey is to get indicators on reported, accused and convicted adult perpetrators of criminal offences which are an important tool to study the structure of criminality and decisions of criminal procedure bodies.*

U 2018. godini tužilaštva u Bosni i Hercegovini riješila su 22.646 izvještaja (prijava) o počinjenom krivičnom djelu za punoljetna lica, što je u odnosu na prethodnu godinu manje za 2.530 prijava ili 10,05%. Od ukupnog broja prijava 89,0% odnosi se na poznate počinioce, a 11,0% na nepoznate počinioce. Ujedno, od ukupnog broja prijavljenih 90,2% odnosi se na prijavljene muškarce.

*In 2018, Public Prosecutor's Office in Bosnia and Herzegovina resolved 22.646 reports (charges) on perpetrated criminal offences for adult persons, which was 2.530 charges lower or 10,05% less in comparison with the previous year. Out of the total number of reported adult persons 89,0% is referred to known perpetrators and 11,0% to unknown perpetrators. Also in the total number of reported persons 90,2% is referred to male perpetrators.*

U istom periodu, doneseno je 11.267 odluka (optužbi), što je u odnosu na prethodnu godinu 183 optužbe (ili 1,6%) manje. Ukupan broj osuđenih punoljetnih lica je 10.306, što je u odnosu na prethodnu godinu 2,13% manje. Od ukupnog broja osuđenih, 93,47% sudskih presuda izrečeno je muškarcima.


*In the same period, 11.267 decisions (charges) were made, which was 183 charges (or 1,6%) less in comparison with the previous year. The total number of convicted adult perpetrators is 10.306, which is in comparison with the previous year 2,13% less. In the total number of convicted persons, 93,47% of cases were court verdicts against male perpetrators.*

Imovinska krivična djela bila su najbrojnija. Kod prijavljenih lica udio imovinskih krivičnih djela u odnosu na ukupan broj iznosio je 38,02%, kod optuženih 33,38% i osuđenih 32,83%.

*Criminal offences against property were the most represented. In the number of reported persons, participation of property crime was 38,02%, while for accused this percentage was 33,38% and for convicted 32,83%.*

*Graph 1. Adult perpetrators of criminal offences in Bosnia and Herzegovina, year 2018*




Grafikon 2. Prijavljena punoljetna lica – poznati i nepoznati punoljetni počinioци krivičnih djela, 2018. godina


Grafikon 3. Odluke tužilaštava prema grupama krivičnih djela, 2018. godina

## METODOLOŠKA OBJAŠNJENJA

### Izvori i metode prikupljanja podataka

Agencija za statistiku BiH na osnovu Zakona o statistici Bosne i Hercegovine ("Službeni glasnik BiH", br.26/04 i 42/04) objavljuje podatke o prijavljenim, optuženim i osuđenim punoljetnim licima u Bosni i Hercegovini u 2018. godini.

Podatke o punoljetnim počinjocima krivičnih djela Agencija za statistiku BiH agregira na osnovu statističkih istraživanja o kriminalitetu koja se provode u Federalnom zavodu za statistiku, Republičkom zavodu za statistiku Republike Srpske i Brčko distriktu BiH.

### Cilj istraživanja

Cilj statističkog istraživanja jesu pokazatelji o punoljetnim prijavljenim, optuženim i osuđenim počinjocima krivičnih djela, prema odlukama tužilaštava i sudova, prema grupama krivičnih djela i prema izrečenim krivičnim sankcijama, koji su važan instrument za proučavanje strukture kriminaliteta i odluka tijela krivičnog postupka.

### Obuhvat i uporedivost

Obuhvat kriminaliteta kao društveno negativne pojave je potpun jer se statističkim istraživanjima obuhvaćaju punoljetni počinjoci krivičnih djela i punoljetni počinjoci prekršaja protiv kojih je vođen i okončan zakonom utvrđen postupak.

Ovim statističkim istraživanjem obuhvaćena su punoljetna prijavljena, optužena i osuđena lica u Bosni i Hercegovini prema grupama krivičnih djela.

### Definicije

**Kriminalitet** u smislu statističkih istraživanja obuhvata pojavu od podnošenja prijave za počinjeno krivično djelo i prekršaj do pravomočnog okončanja postupka od strane nadležnog tijela (državnog odvjetništva, prvostepenih sudova i drugih prekršajnih tijela).

Jedinice posmatranja su punoljetni počinjoci krivičnih djela i punoljetni počinjoci prekršaja.

**Krivično djelo** je protivpravno djelo kojim se povređuju ili ugrožavaju zaštićene vrijednosti i koje je zbog svoje opasnosti u zakonu određeno kao krivično djelo i za njega propisana krivična sankcija.

**Punoljetni počinjoci krivičnih djela** jesu osobe koje su u vrijeme počinjenja krivičnog djela imale navršenih 18 godina života i protiv kojeg je postupak po krivičnoj prijavi završen.

**Prijavljeno lice – poznati počinilac** je punoljetni učinilac krivičnog djela protiv kojeg je završen postupak odlukom kojom je: izdata naredba ili doneseno rješenje o neprovođenju istrage, prekinuta ili obustavljena istraga ili je

## NOTES ON METHODOLOGY

### Data source

*Agency for Statistics of Bosnia and Herzegovina publishes data on reported, accused and convicted adult persons in Bosnia and Herzegovina in year 2018, in accordance with the Law on Statistics of Bosnia and Herzegovina ("Official Gazette of Bosnia and Herzegovina", No. 26/04 and 42/04).*

*Data on adult persons who committed a crime, Agency for Statistics of Bosnia and Herzegovina aggregates by obtaining statistical crime surveys from Federal Statistical office of Federation of BiH, Institute of Statistics of Republic of Srpska and District Brčko of BiH.*

### Survey objective

The aim of the statistical survey are indicators on reported, accused and convicted adult offenders, according to the decisions of prosecutors' offices and courts, according to groups of criminal offences under the penalties, which are an important instrument for studying the structure of crime and decisions of the criminal proceedings.

### Coverage and comparability

*Coverage of crime as a negative social phenomena it's comprehensive because its complete statistical surveys include adult criminal offenders and adult perpetrators who committed offences against whom are conducted and statutory procedures completed.*

*This statistical survey covers reported, accused and convicted adult persons in Bosnia and Herzegovina by type of criminal groups.*

### Definitions

*Crime in terms of statistical research ranges from the filing of a criminal offence and a misdemeanor to a final conclusion of the proceedings by the competent authority (the State Attorney's Office, first instance courts and other judicial bodies).*

*Units are the adult perpetrators of crimes and offences.*

*Criminal offence is an unlawful act violating or threatening protected rights, which is, due to its dangerousness, designated as a criminal offence in the Law, and a criminal sanction is prescribed for it.*

*Adult perpetrator of a criminal offence is a person who, at the time of the offence, was 18 years of age and against whom procedure on criminal charge was either terminated.*

*Reported person – known perpetrator is an adult perpetrator of a criminal offence against whom procedure was terminated by one of the following decisions: order issued or decision passed not to conduct investigation,*

**Prijavljeno lice – nepoznati počinilac** je lice protiv kojeg je tužilaštvo podnesena krivična prijava, a koje je po isteku godine dana od dana podnošenja prijave i dalje nepoznato.

**Optuženo lice** jest punoljetno lice protiv koje je sudu podnijeta optužnica, optužni prijedlog ili privatna tužba, protiv kojeg je postupak pravosnažno završen odlukom suda kojom se postupak obustavlja, optužba odbacuje, oslobađa ili odbija ili se lice proglašava krivim.

**Osuđeno lice** je punoljetno lice koje je proglašeno krivim i prema kome su izrečene krivične sankcije: zatvor, novčana kazna, uslovna osuda, rad za opće dobro na slobodi, sudska opomena ili je proglašeno krivim, a oslobođeno od kazne.

*investigation interrupted or terminated, or indictment filed.*

**Reported person – unknown perpetrator** is a person against whom a criminal charge was filed to a Public Prosecutor's Office, and who remained unknown one year from the charge submission date.

**Accused person** is an adult person against whom an indictment, a complaint or a private lawsuit was filed to a court, and against whom a procedure was legally ended by a decision of the court either to terminate the procedure, to dismiss or reject the charge, to acquit the person of the charge or to pronounce the person guilty.

**Convicted person** is an adult person who was found guilty of a criminal offence and on whom one of the criminal sanctions was imposed (imprisonment, fine, conditional sentence, community service, judicial admonition), or a person who was found guilty and released from punishment.
