#### INDEKS PROIZVOĐAČKIH CIJENA INDUSTRIJE U BOSNI I HERCEGOVINI U OKTOBRU 2020. GODINE

*PRODUCER PRICE INDEX IN BOSNIA AND HERZEGOVINA IN OCTOBER 2020*

##### **Proizvođačke cijene industrijskih proizvoda (ukupno)**

U oktobru 2020. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda za ukupnu industriju su zabilježile rast nivoa cijena za 0,1%, dok u odnosu na isti mjesec prethodne godine zabilježile pad za 0,8%.

##### **Proizvođačke cijene industrijskih proizvoda na domaćem tržištu**

U oktobru 2020. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda na domaćem tržištu nisu zabilježile promjenu nivoa cijena za 0,3%, dok su u odnosu na isti mjesec prethodne godine zabilježile pad za 0,6%.

##### **Proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu**

U oktobru 2020. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu su zabilježile rast za 0,1%, dok je u odnosu na isti mjesec prethodne godine zabilježen pad nivoa cijena za 1,1%.

##### **Proizvođačke cijene industrijskih proizvoda (ukupno)**

U oktobru 2020. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda su zabilježile rast nivoa u Energiji za 0,1%, Intermedijarnim proizvodima za 0,2% i Kapitalnim proizvodima za 0,1%, dok je pad zabilježen u Trajnim proizvodima za 0,3% te Netrajnim za 0,1%.

##### ***Producer prices of industrial products (total)***

*In October 2020 as compared to previous month, Producer prices of industrial products for total industry recorded a price level increase by 0,1%, whilst compared to the same month of the previous year they recorded a decrease by 0,8%.*

##### ***Industrial producer prices on the domestic market***

*In October 2020 as compared to a previous month, the producer prices of industrial products did not record a price level change, whilst as compared to the same month of previous year they recorded a decrease by 0,6%.*

##### ***Industrial producer prices on the nondomestic market***

*In October 2020 as compared to a previous month, the producer prices of industrial products recorded a price increase by 0,1%, whilst as compared to the same month of previous year they recorded a decrease by 1,1%.*

##### ***Producer prices of industrial products (total)***

*In October 2020 as compared to previous month the producer prices of industrial products increased in Energy by 0,2%, Intermediate products by 0,1% and Capital products by 0,1%, whilst the decrease was recorded in Consumer durables by 0,3% and Non-durables by 0,1%.*

U oktobru 2020.godine u poređenju sa istim mjesecom prethodne godine proizvođačke cijene više su u Kapitalnim proizvodima 1,1% i Trajnim potrošačkim dobrima za 0,7%, dok je pad zabilježen u Energiji za 0,2% te Intermedijarnim proizvodima za 1,4%.

U oktobru 2020. godine u poređenju sa istim mjesecom prethodne godine, zabilježen je rast cijena u Kapitalnim proizvodima za 1,1% i Trajnim dobrima za 0,3%, dok je pad zabilježen u Intermedijarnim proizvodima za 0,9% i Netrajnim dobrima za 0,3%.

#### **Proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu**

U oktobru 2020.godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu više su u Energiji i Intermedijarnim proizvodima za 0,2%, dok je pad zabilježen u Trajnim potrošačkim dobrima za 0,4%.

U oktobru 2020.godine u poređenju sa istim mjesecom prethodne godine proizvođačke cijene industrijskih proizvoda porasle su u Kapitalnim proizvodima za 0,6%, Trajnim proizvodima za 0,8% i Netrajnim proizvodima za 0,6%, dok je pad zabilježen u Energiji za 2,4% i Intermedijarnim proizvodima za 2,0%.

#### **Industrijska područja KD-a.**

##### **Proizvođačke cijene industrijskih proizvoda (ukupno)**

U oktobru 2020. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda su porasle u Vađenju ruda i kamena za 1,8% te u Proizvodnji električne energije za 0,2%.

U poređenju sa istim mjesecom prethodne godine pad nivoa cijena je zabilježen u Vađenju ruda i kamena za 2,7% i Prerađivačkoj industriji za 0,9%, dok je rast zabilježen u Proizvodnji električne energije za 1,0%.

In October 2020 as compared to the same month of previous year, the price increase was recorded in Capital goods by 1,1% and Consumer durables by 0,7%, whilst the decrease was recorded in Energy by 0,2% and Intermediate products by 1,4%.

#### ***Industrial producer prices on the domestic market***

*In October 2020 as compared to the previous month the price increase on domestic market was recorded in Energy by 0,1%, Intermediate products by 0,1%, and Capital products by 0,3%, whilst the decrease was recorded in Consumer non-durables by 0,2%.*

*In October 2020 as compared to the same month of the previous year, the producer prices increased in groups of Capital products by 1,1% and Consumer durables by 0,3%, whilst the decrease was recorded in Intermediate products by 0,9% and Consumer non-durables by 0,3%.*

#### ***Industrial producer prices on the nondomestic market***

*In October 2020 as compared to previous month the price increase on nondomestic market was recorded in Energy and Intermediate products by 0,2%, whilst the increase was recorded in Consumer durables by 0,4%.*

*In October 2020 as compared to the same month of the previous year, the prices increased in Capital products by 0,6%, Consumer durables by 0,8% and Non-durables by 0,6%, whilst the decrease was recorded in Energy by 2,4% and Intermediate products by 2,0%.*

#### ***KD Industrial sections and divisions***

##### ***Producer prices of industrial products (total)***

*In October 2020 as compared to previous month the producer prices increased in Mining and quarrying by 1,8% and in Electricity by 0,2%.*

*In October 2020 as compared to previous month the prices decreased in Mining and quarrying by 2,7% and Manufacturing by 0,9%, whilst the increase was recorded in Electricity by 1,0%.*

U poređenju sa istim mjesecom prethodne godine pad nivoa cijena je zabilježen u Vađenju ruda i kamena za 6,7%, Prerađivačkoj industriji za 1,0% te Proizvodnji električne energije za 4,3%.

### ***Producer prices of industrial products on domestic market***

*In October 2020 as compared to previous month the producer prices increased in Mining and quarrying by 0,6% and Electricity by 0,1%.*

*In October 2020 as compared to the same month of the previous year, the prices decreased in Mining and quarrying by 1,3% and Manufacturing by 0,9%, whilst the increase was recorded in and Electricity by 1,0%.*

### ***Producer prices of industrial products on non-domestic market***

*In October 2020 as compared to previous month the producer prices increased in Mining and quarrying by 10,2% and Electricity by 14,0%, whilst the increase of price levels was recorded in Manufacturing by 0,1%.*

*In October 2020 as compared to previous month the prices decreased in Mining and quarrying by 6,7%, Manufacturing by 1,0% and Electricity by 4,3%.*

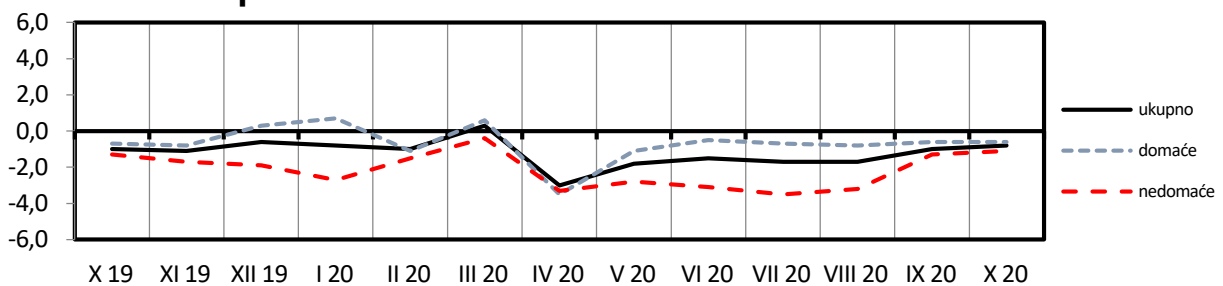

## METODOLOŠKA OBJAŠNENJA

### Definicija indeksa proizvođačkih cijena

**Indeks cijena proizvođača industrijskih proizvoda** je kratkoročni statistički indikator koji predstavlja mjeru promjena cijena proizvoda koje industrijska preduzeća proizvode i prodaju na domaćem i nedomaćem tržištu.

### Namjena

Prvenstvena namjena Indeksa cijena proizvođača industrijskih proizvoda je da služi kao indikator opće inflacije. Zatim služi i kao indikator makroekonomskih performansi, eskalator za prilagođavanje cijena u dugoročnim ugovorima, deflator nominalnih vrijednosti outputa ili međufazne potrošnje u ostvarenom obimu proizvodnje i deflator za nominalne vrijednosti kapitalnih troškova u nacionalnim računima, važan alat pri kreiranju i vođenju monetarnih i fiskalnih politika, kao i za donošenje informisanih ekonomskih odluka u privatnom sektoru.

### Indeks cijena proizvođača industrijskih proizvoda u Bosni i Hercegovini

Indeks cijena proizvođača u Bosni i Hercegovini se izračunava na osnovu reprezentativne liste proizvoda i njihovih proizvođača koju čine oko 570 proizvodnih subjekta. Svakog mjeseca se prikuplja oko 4255 cijene direktno od samih proizvođača putem jedinstvenog obrasca koji je nastao kao rezultat saradnje sa italijanskim partnerima.

### Obuhvat indeksa

Osnovni kriterij pri odabiru proizvoda i usluga koji će se mjesečno posmatrati je bio kriterij proizvođača i proizvoda sa najvećom realizacijom na tržištu a prema podacima dobijenim putem godišnjeg istraživanja o industriji (IND-21). Sami proizvođači i proizvodi su odabrani od strane entitetskih Zavoda za statistiku dok su pojedinačne stavke unutar tih proizvoda odabrane od strane samih proizvođačkih preduzeća.

### Snimanje cijena

Prodajna cijena proizvođača industrijskih proizvoda na domaćem tržištu je cijena po kojoj proizvođač prodaje svoje proizvode redovnim kupcima na domaćem tržištu u najvećim količinama franko utovareno na vagon (kamion) u mjestu proizvođača. U tu cijenu ulaze regresii ukoliko ih proizvođač ostvaruje a isključuju se trgovački rabati i popusti koje prodavac odobrava kupcu PDV i akcize.

## NOTES ON METHODOLOGY

### Definition of producer price index

**Producer price index** is a short-term statistical indicator that represents the measurement of change of prices of industrial products produced and sold by enterprises on domestic and non-domestic market.

### Purpose

This statistical indicator serves as the measure of inflation. It can also serve as the indicator of economical performances, escalator in long-term contracts, deflator for output values, intermediate consumption, and capital consumption in National Accounts and as a important tool in creating monetary and fiscal politic.

### Producer price index in Bosnia and Herzegovina

PPI in Bosnia and Herzegovina is calculated based on the representative list of products and it's producers making a sample of cca.570 producers. Each month 4255 prices are collected directly from producers throug the unique questionnaire created in cooperation with Italian experts.

### Coverage

The main criterion for selecting the sample of enterprises, products and services that are surveyed was the volume of production and selling on the domestic market got from the Annual survey on Industrial production (IND-21). Entities institutes of statistics have created the sample of enterprises and products and the enterprises itself have choosen the items to be priced.

### Prices collection

The price that is to be collected each month on the domestic market represents a price for which producer sells his products to the regular costumers on the domestic market at maximum volume franco loaded into a wagon (truck) at the producers location. It includes reimbursements if applicable, and it excludes commercial rabattes disscounts VAT and excises.



Cijena proizvođača proizvoda za strano tržište je cijena na nacionalnoj granici- FOB (free on board) što znači da prodavac plaća prijevoz robe do luke isporuke i troškove utovara a kupac plaća prijevoz osiguranje troškove istovara te prijevoz od određene luke do krajnjeg mjesta korištenja.

Pomenuta cijena isključuje PDV i slične poreze direktno vezane za promet kao i sve takse i namete na proizvode i usluge koje preduzeća plaćaju dok se eventualno primljene subvencije na proizvode dodaju.

Sve cijene se prikupljaju mjesečno u periodu prikupljanja od 21. prošlog mjeseca do 20. tekućeg mjeseca. Obrazac se dostavlja proizvođačkim preduzećima koji ga popunjenog dostavljaju u centrale Entitetskih zavoda za statistiku koje vrše obradu podataka te izračunate indekse dostavljaju Agenciji za statistiku BiH radi njihova agregiranja za nivo Bosne i Hercegovine.

### **Ponderi**

Ponderi koji se primjenjuju za izračunavanje indeksa proizvođačkih cijena predstavljaju relativno učešće odabranih proizvoda u ukupnoj vrijednosti prodaje industrijskih proizvoda na domaćem tržištu. Za ovo istraživanje primjenjuju se ponderi baziraju na podacima Godišnjeg izvještaja industrije (IND-a 21) iz 2015. godine dok se na nivou države na relativnom učešću pojedinačnog entiteta u ukupnoj proizvodnji iz 2015. godine. Svake godine se ponderi korigiraju kretanjem cijena iz prethodne godine.

### **Klasifikacija**

Klasifikacija industrijskih proizvoda se bazira na Nomenklaturi industrijskih proizvoda BiH 2010. zasnovane na PRODCOM listi 2010.

### **Agregiranje**

Pri izračunavanju indeksa proizvođačkih cijena prvo se izračunavaju elementarni indeksi na nivou proizvoda koji predstavljaju omjer cijene iz tekućeg perioda i bazne cijene (cijene iz decembra prethodne godine). Pri tome se kao mjera srednje vrijednosti koristi prosta geometrijska sredina. Iz elementarnih indeksa se računaju agregatni indeksi klasa područja podpodručja i ukupan indeks korištenjem Laspyres-ove formule za ponderiranu aritmetičku sredinu.

*The producer price for non-domestic market is a price on a national border- FOB (free on board) which means that a seller pays the transport to the port deliverance loading costs and a buyer pays costs of transport assurance unloading and trasport to it's final destination.*

*This price exclude VAT and similar taxes directly affecting turnover and all taxes and fees on products and services that enterprises pay. The subventions received are added.*

*All the data should be submitted to the Entities institutes each month for the period from 21<sup>th</sup> of the previous to the 20<sup>th</sup> of current month. The Entities Institutes completes the data entry process and calculates the PPI for the level of Entity and forward the indices to the Agency for statistics of B&H that calculates the index for the state level.*

### **Weights**

*Weights applied for the calculation of producer price index represent the relative share of selected products in the total value of sales of industrial products on the domestic market. Weights are based on the results of the Annual Survey on Industrial production (IND-21) for the year 2015. but for the state level the weights are based on the relative share of each Entity in the total production also from the year 2015. Each year the weights are price updated.*

### **Classification**

*Classification of industrial products is based on the Nomenclature of Industrial Products in B&H 2010 based on the PRODCOM List 2010.*

### **Aggregation**

*The first step in calculation of PPI is the calculation of elementary indices at the level of each products. that is the ratio between the current month price and the base price (from December of the previous year). After that the simple geometric mean is applied. The second step is the calculation of the indices of higher aggregates such as classes divisions subsections sections and overall index using the Laspyeres's formula for the weighted arithmetic mean.*
