FOREWORD

The Agency for Statistics of Bosnia and Herzegovina performs a regular processing and presentation of international trade in goods of BiH.

Basic principles, standards and procedures for the implementation of international trade in goods survey have been based on the recommendations provided by the United Nations – publication International Merchandise Trade Statistics: Concepts and Definitions⁹. This publication is used as the basis for Eurostat's methodology on international trade in goods statistics. Statistical monitoring of this trade is designed fully in accordance with the Law on Customs Policy of BiH (Official Gazette of BiH, 57/04, 51/06, 93/08, 54/10 and 76/11) and the Law on Customs Tariff of BiH (Official Gazette of BiH, 1/98, 5/98, 7/98, 22/98, 31/02, 19/03, 32/04, 48/05, 76/06, 35/09, 14/10 and 58/12).

Also, in line with the Law on Statistics of BiH (Official Gazette of BiH, 26/04) Agency for Statistics of BiH is the competent body to determine the statistical standards as well as methodology defining methods of data collection, processing and publication.

The publication has been prepared on the basis of available statistical data for 2012 and represents implementation of one of the activities covered by the 2013-2017 Multi-Annual Programme of BiH. The source of data is the Indirect Taxation Authority of BiH. This is the ninth publication in a row which is entirely focused on international trade in goods of BiH. Data on export and import price indices of BiH (based on export and import unit value indices) can be found in the publication as well.

It should be noted that the data on international trade in goods of BiH have been processed in line with EU statistical standards and procedures following a system of special trade (relaxed definition). To this end, data could differ in terms of data published by other institutions.

We are firmly determined to invest all our efforts in increasing the coverage and data quality in our future publications and accordingly, your valuable suggestions and comments would be appreciated very much.

INTERNATIONAL TRADE IN GOODS OF BiH

1. METHODOLOGY

Data sources and data collection methods

Single Administrative Document (SAD) is used as the main data source for BiH international trade in goods statistics.

Single Administrative Document is a document lodged by declarer (business entity or other authorized person, i.e. freight forwarder) to a customs office for customs clearing. In general, BiH international trade in goods statistics cover all transactions in goods between residents and non-residents entering or leaving the customs territory of Bosnia and Herzegovina and therefore, increasing or decreasing material resources of the country, regardless changes in ownership.

Agency for Statistics of BiH obtains data on international trade from Indirect Taxation Authority of BiH in line with the Protocol on Cooperation agreed and signed between these two institutions.

Data received from Indirect Taxation Authority, in line with UN recommendations, may be combined with data provided directly by enterprises engaged in export/import transactions, with the aim that BiH international trade in goods statistics provide as high quality and reliable data as possible to all users.

Observation unit

Observation unit in the international trade in goods statistics is any delivery of goods, exported or imported, if it is homogenous by product type, country of destination/origin, mode of payment and the time of border crossing.

Classifications

With adoption of the Law on Customs Tariff of BiH (Official Gazette of BiH, 1/98) Article 2, Bosnia and Herzegovina has adopted HS WCO classification. By decision to apply Article 2 of the Law on Customs Tariff of BiH (Official Gazette of BiH, 6/98), the tariff item of BiH Customs Tariff is composed of ten digits and accordingly, the seventh and eighth digits are harmonized with the EU classification (Combined Nomenclature-CN). However, the ninth and tenth digits are used to go beyond to provide a classification to satisfy the BiH specific needs.

Harmonized System (HS) is an international classification of goods by numerical coding system, which has been developed by the World Customs Organization (WCO). HS classification contains sections, chapters, headings and sub-headings and corresponding numerical codes. HS covers 21 sections (marked as I through XXI) and 97 chapters (marked as 01 through 97).

Standard International Trade Classification - SITC rev.4 was accepted by the United Nations Statistical Commission in March 2006. SITC includes 2.970 items, 1.023 subgroups, 261 groups, 67 divisions and 10 sections. Standard International Trade Classification was developed on the basis of Harmonized System and represents one of the basic classifications for international trade in goods statistics.

Data coverage

BiH international trade in goods statistics apply the special trade system (relaxed definition) in line with Eurostat's recommendations. Repair of goods is excluded from data processing.

The statistical value of exported and imported goods is to be determined at the national border, which is in accordance with the international standards and recommendations of United Nations (UN) and European Commission (EC).

In the case of exporting goods, FOB-type values are used, meaning that the statistical value of goods comprises the invoiced value agreed between buyer and seller, as well as the costs of transport and insurance from a destination in BiH to the BiH border crossing.

In the case of importing goods, CIF-type values are used, meaning that the statistical value of imported goods comprises the contracted price of goods agreed between buyer and seller (transaction value of goods) and the costs of international freight and insurance to the BiH border crossing.

Currency conversion

In BiH international trade in goods statistics data are presented in KM, EUR and USD. Data in EUR and USD are obtained by converting KM to EUR and USD using yearly exchange rates for mentioned currencies.

Partner country

Pursuant to UN and EU methodological standards, partner country for import is the country of origin of goods, and the country of consignment is taken as additional information. The country of origin of goods is the country in which goods were manufactured, and the country of consignment is the country from which the goods were dispatched to the importing country.

Pursuant to the same standards, partner country in the case of export is the country of the last known destination.

In BiH, pursuant to the above, the country of origin of goods is taken as importing country, but, in the case of import after outward processing and import of goods from chapter 97 of Harmonized system, as well as incorrect codes or empty boxes for the country of origin in the customs database, the country of consignment is taken as importing country.

The country of last known destination is taken as exporting country.

Data confidentiality

Pursuant to the BiH Law on Statistics, Articles 23 and 26 (Official Gazette of BiH, 26/04), Agency for Statistics of BiH is responsible to ensure confidentiality of individual data and statistical units when collecting, processing and disseminating data. Data aggregation level in accordance with HS or SITC classifications has to respect the principle of confidentiality of individual data.

Data dissemination





2.1.2. BiH trade balance 2003 - 2012












2.9.1. BiH export and import in 2012 by NACE rev.2 sections





2.10.1. BiH export in 2012 by statistical procedures




2.10.2. BiH import in 2012 by statistical procedures


2.11.1. BiH export and import in 2012 by Main Industrial Groupings





3.1.2. BiH trade balance 2003 - 2012












3.9.1. BiH export and import in 2012 by NACE rev. 2 sections





3.10.1. BiH export in 2012 by statistical procedures




3.10.2. BiH import in 2012 by statistical procedures


3.11.1. BiH export and import in 2012 by Main Industrial Groupings





4.1.2. BiH trade balance 2003 - 2012












4.9.1. BiH export and import in 2012 by NACE rev. 2 sections





4.10.1. BiH export in 2012 by statistical procedures




4.10.2. BiH import in 2012 by statistical procedures


4.11.1. BiH export and import in 2012 by Main Industrial Groupings

5. COMMENTARY

(International trade in goods of BiH 2012 – USD)

In 2012, export amounted to 5 161,8 million USD which is 11,7% lower than the previous year.

In 2012, import amounted to 10 019,1 million USD which is 9,3% lower than the previous year.

In 2012, trade deficit amounted to 4 857,3 million USD.

Regarding the sections of Harmonized System (HS 2007), the following should be noted:

The highest export share in 2012 was obtained in the section XV "Base Metals and Articles of Base Metals" amounting to 1 253,8 million USD or 24,3% of the total export, as well as in the section V "Mineral products" amounting to 573 million USD or 11,1% of the total export.

In 2012, the highest import share was obtained in the section V "Mineral products" amounting to 2 121 million USD or 21,2% of the total import, as well as in the section XVI "Machinery; Electrical Equipment" amounting to 1 235,7 million USD, or 12,3% of the total import.

Regarding the geographical distribution of international trade in goods of BiH, the following should be noted:

In 2012, the highest export was to Germany amounting to 794,9 million USD or 15,4% of the total export. Regarding the neighbouring countries, the highest export was to Croatia amounting to 765,2 million USD or 14,8% of the total export.

Regarding the regional groups, in 2012, the highest export was to EU amounting to 2 990,4 million USD or 57,9% of the total export. Export to CEFTA countries amounted to 1 631 million USD or 31,6% of the total export.

In 2012, the highest import was from Croatia amounting to 1 446,8 million USD or 14,4% of the total import. Regarding the neighbouring countries (besides Croatia), a significant import in 2012 was from Serbia amounting to 940,3 million USD or 9,4% of the total import.

Regarding the regional groups, in 2012, the highest import was from EU amounting to 4 701,9 million USD or 46,9% of the total import. Given the EU countries, the highest import was from Germany, amounting to 1 133,6 million USD or 11,3% of the total import. Import from CEFTA countries amounted to 2 523,3 million USD or 25,2% of the total import.

Regarding the sections of Standard International Trade Classification (SITC rev.4), the following should be noted:

In 2012, the highest export share was obtained in the section (6) "Manufactured goods classified by material" amounting to 1 417,9 million USD or 27,5% of the total export.

A significant export was obtained in the section (8) "Miscellaneous manufactured articles" amounting to 1 209,8 million USD or 23,4% of the total export.

In 2012, the highest import share was obtained in the section (3) "Mineral fuels and lubricants" amounting to 2 056,7 million USD or 20,5% of the total export.

A significant import share was obtained in the section (6) "Manufactured goods classified by material" amounting to 1 918,3 million USD or 19,1% of the total import.

6. METHODOLOGY

Data source and methods for data collection

Data source for the calculation of export and import price indices (unit values) is Single Administrative Document (SAD) that the Agency for Statistics of BiH obtains from the Indirect Taxation Authority for the processing of data on international trade in goods of BiH on monthly bases.

Observation unit in the international trade in goods statistics is any delivery of goods, exported or imported, if it is homogeneous by product type, country of origin/destination, mode of payment and the time of border crossing, and for which SAD is submitted. Within the SAD, the products are classified according to Customs Tariff of BiH, which is in line with the Combined Nomenclature (CN) used in the European Union. The Customs Tariff of BiH comprises around 10 000 products, and thus for that number of records the export and import price indices (unit values) could be calculated. However, the prices (unit values) in such a low degree of data aggregation are less significant for the analysts, and it is necessary to calculate the group index for a particular activity or the economy as a whole.

Classifications

Classification NACE rev. 2 is used for presenting the data by activities.

Standard International Trade Classification - SITC rev.4 was adopted by the United Nations. This classification is recommended for the analysis of international trade in goods. It contains 2970 basic headings, 1023 subgroups, 262 groups, 67 divisions and 10 sections.

Data coverage

The following records are excluded from the process of calculation of the export and import price indices (unit values):

- products without any information on the amount (whether of net mass or value) or which do not appear during some of the observation periods,
- records whose elementary index value is outside the interval (0.5, 2), i.e. the interval [0.5* median, 2* median], where the median is calculated according to KD BiH (NACE rev.2) divisions,
- electricity - because the calculation is conducted on the net mass, not the supplementary unit.

Calculation of indices

The indices are calculated according to the Paasche formula, as follows:

where:

cn8 - the CN product

Q - quarter

Y - year

Val - value

Ind - elementary index that is calculated by the formula:

$$Ind(cn8, 1Q, Y) = \frac{unit_value(cn8, 1Q, Y)}{unit_value(cn8, Y-1)}$$

(unit value - the unit value for a given CN code in a given quarter, in a given year)

Base year is 2010.

Currency conversion

Official data on the value of export and import which are processed by the Agency for Statistics of BiH are expressed in KM. For the purpose of comparability, export and import are expressed in euros and U.S. dollars as well. Data on the total value of export/import expressed in KM do not show the same dynamics of movement as the ones expressed in U.S. dollars. This difference is caused by the change of rate of the U.S. dollar in relation to KM by which the conversion is conducted.

Data dissemination

Export and import price indices (unit values) are calculated quarterly from the data expressed in KM, euros and U.S. dollars and in comparison to the previous year, while all other indices are calculated from them. Indices are monitored and published according to NACE rev. 2 divisions and SITC rev. 4 sections. Annual indices represent the arithmetic average of quarterly indices.







10. COMMENTARY

(Export and import price indices of BiH 2012/2011 - USD)

According to the final data for 2012, there was an increase in export prices by 7,3% compared to 2011 with 2010 as base year.

As for import prices, there was an increase by 11,7% compared to 2011 with 2010 as base year.

According to the NACE rev.2 sections and divisions, the following should be noted:

The highest increase in export prices was in the section "Agriculture, forestry and fishing" by 12,2%, "Mining and quarrying" by 9,1% and "Manufacturing" by 7,2%.

Within these sections, one can single out the divisions "Manufacture of tobacco products" with the export price increase by 24,9% and "Manufacture of leather and related products" with the increase by 19,1%.

The highest increase in import prices was in the section "Agriculture, forestry and fishing" by 21,1%, "Mining and quarrying" by 29,3% and "Manufacturing" by 8,7%.

Within these sections, one can single out the divisions "Extraction of crude petroleum and natural gas" with the import prices increase by 44,3% and "Manufacture of coke and refined petroleum products" with the increase by 38,3%.

According to the Standard International Trade Classification (SITC rev.4) sections, the following should be noted:

The highest increase in export prices was recorded in the section "Animal and vegetable oils and fats" by 31,6%. Import prices had the highest increase in the section "Mineral fuels and lubricants" by 33,1%.
