## POLJOPRIVREDA, OKOLIŠ I REGIONALNE STATISTIKE AGRICULTURE, ENVIRONMENT AND REGIONAL STATISTICS

### KLANJE STOKE I PERADI U KLAONICAMA, PROSINAC 2021 SLAUGHTERING OF LIVESTOCK AND POULTRY IN SLAUGHTERHOUSES, DECEMBER 2021

U prosincu 2021. godine povećan je broj zaklanih goveda za 4,45%, ovaca za 10,44%, svinja za 12,37% i peradi za 2,13% u usporedbi sa istim razdobljem 2020. godine.

Neto težina zaklanih goveda je povećana za 8,32%, ovaca za 5,43% i svinja za 9,55% dok je neto težina zaklane peradi smanjena za 0,78% u usporedbi sa istim razdobljem 2020. godine.


In December 2021 the number of slaughtered cattle increased by 4,45%, sheep by 10,44%, pigs by 12,37% and poultry by 2,13% in relation with the same period of 2020.

The net weight of slaughtered cattle increased by 8,32%, of slaughtered sheep by 5,43% and of slaughtered pigs by 9,55%, while the net weight of slaughtered poultry decreased by 0,78% in relation with the same period of 2020.

### Metodološka objašnjenja

Podaci o klanju stoke i peradi dobiveni su agregiranjem podataka na osnovu usporedivih mjesecnih statističkih istraživanja koja provode entitetski zavodi za statistiku i podružnica Distrikt Brčko.

Poslovni subjekti i dijelovi poslovnih subjekata dostavljaju podatke na osnovu knjigovodstvene evidencije, dok se za obrtničke klaonice podaci dobivaju od nadležnih općinskih službi (veterinarsko – inspekcijskih) na osnovu raspoložive evidencije.

### Definicije

**Bruto težina** jeste težina stoke i peradi prije klanja.

**Neto težina** jeste težina očišćenog trupa, zaklane stoke i peradi bez kože, krvi, glave (osim kod odojaka i peradi), utroba, prednjih nogu do koljena i stražnjih nogu do skočnog zgloba.

**Randman** zaklane stoke i peradi predstavlja postotni odnos težine zaklane stoke i peradi (neto težine) i težine žive stoke i peradi (bruto težine), a iskazuje se u postocima s jednom decimalom.

### Notes on methodology

The data on slaughter of livestock and poultry are result of aggregation of comparable the data from monthly statistical surveys conducted Entity institutes for statistics and by the Bureau in Brcko District.

Data on legal entities and parts of legal entities are submitting data based on book-keeping, whereas for entrepreneurs avbattoirs data are given from approved municipal (veterinarian – inspection) depeartment at the basis of available evidence.

### Definition

**Gross weight** is the weight of livestock and poultry before slaughtering.

**Net weight** is the weight of dressed carcass of slaughtered animals without skin and blood, eviscerated and beheaded (excluding piglets and poultry), and after removal offore ends and hind legs with knuckle.

**Coefficient of utilisation** of slaughtered livestock and poultry is a percentage ratio of the weight of the slaughtered cattle and poultry (net weight) and the weight of livestock and live poultry (gross weight), and it is presented in percentage calculated to one decimal place.
