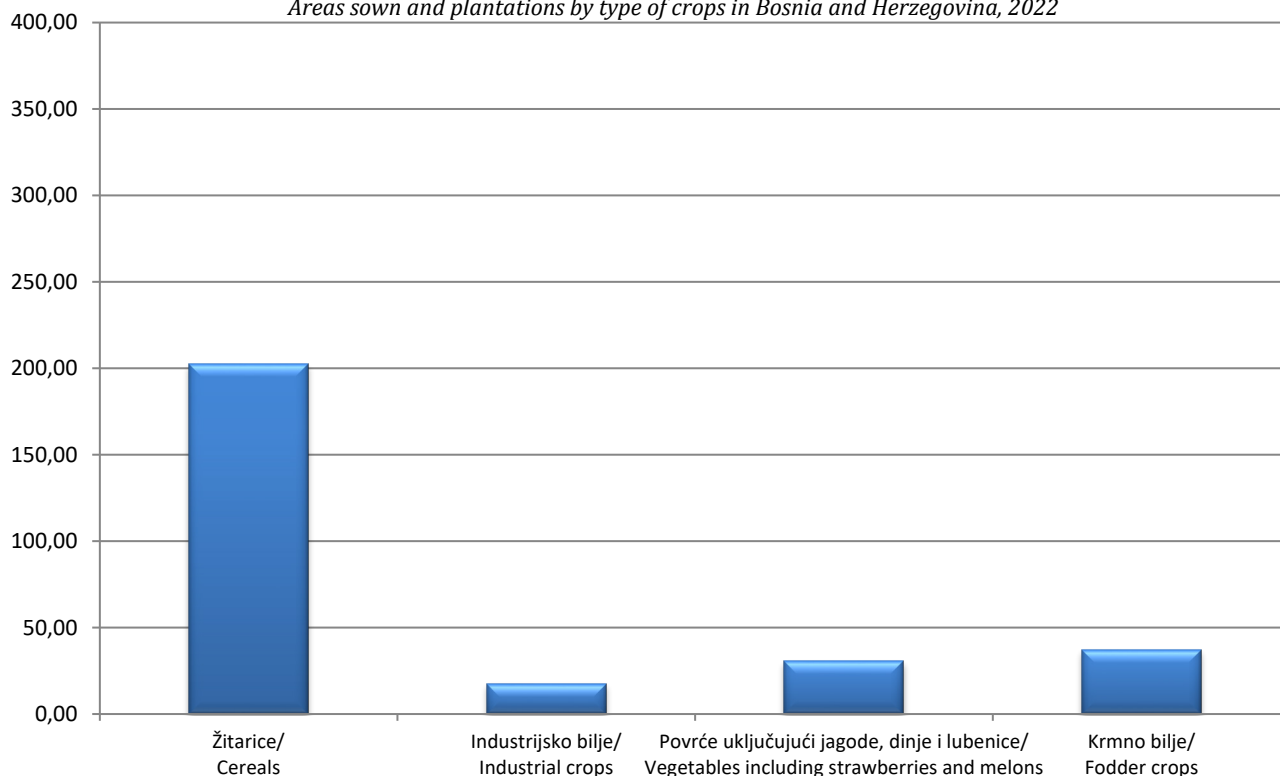
Učešće glavnih vrsta usjeva je sljedeće:

Žitarice 69,45%, industrijsko bilje 6,01%, povrće uključujući jagode, dinje i lubenice 10,47% i krmno bilje 12,81%. Ostali usjevi su zastupljeni sa 1,25 %.

The participation of main crops is as follows:

Cereals 69,45%, industrial crops 6,01%, vegetables including strawberries and melons 10,47%, fodder crops 12,81%. Other crops are participation with 1,25%.

## METODOLOŠKA OBJAŠNENJA

### Izvori i metode prikupljanja

Podaci su prikupljeni na bazi statističkih istraživanja koja su proveli Agencija za statistiku Bosne i Hercegovine, Federalni zavod za statistiku Federacije Bosne i Hercegovine i Republički zavod za statistiku Republike Srpske.

Istraživanja se zasnivaju na Zakonu o statistici na entitetskom i na državnom nivou u Bosni i Hercegovini kao i na EU legislativi.

### Jedinice posmatranja

Istraživanje je provedeno na ciljanom, stratifikovanom, reprezentativnom uzorku porodičnih poljoprivrednih gazdinstava (PPG) na teritoriji Bosne i Hercegovine, a uključena su i sva poljoprivredna preduzeća i preduzetnici. Uzorak je na bazi okvira iz Popisa stanovništva 2013.

## NOTES ON METHODOLOGY

### Sources and collection methods

The data in this release were collected through the statistical surveys conducted by Agency for statistics of Bosnia and Herzegovina, Institut for statistics of Federation of Bosnia and Herzegovina and Republika Srpska Institute of statistics.

Surveys are based on statistical legislation in Bosnia and Herzegovina and EU legislation.

### Reporting units

The survey was conducted on a targeted, stratified, representative sample of family agricultural holdings (FAH) in the territory of Bosnia and Herzegovina and included all agricultural enterprises and entrepreneurs. The sample is on the base of frame from Population Census 2013.
