#### KLANJE STOKE I PERADI U KLAONICAMA, JANUAR 2024.

##### SLAUGHTERING OF LIVESTOCK AND POULTRY IN SLAUGHTERHOUSES, JANUARY 2024

U januaru 2024. godine smanjen je broj zaklanih goveda za 24,43%, ovaca za 42,22% i peradi za 3,30%, dok je broj zaklanih svinja povećan za 0,28% u odnosu na isti period 2023. godine.

Neto težina zaklanih goveda je smanjena za 24,34%, ovaca za 45,45%, svinja za 0,34% i peradi za 3,66% u odnosu na isti period 2023. godine.

In January 2024 the number of slaughtered cattle decreased by 24,43%, sheep by 42,22% and poultry by 3,30%, while the number of slaughtered pigs increased by 0,28% in relation with the same period of 2023.

The net weight of slaughtered cattle decreased by 24,34%, of slaughtered sheep by 45,45%, of slaughtered pigs by 0,34% and of slaughtered poultry by 3,66% in relation with the same period of 2023.

### Metodološka objašnjenja

Podaci o klanju stoke i peradi dobiveni su agregiranjem podataka na osnovu uporedivih mjesečnih statističkih istraživanja koja provode entitetski zavodi za statistiku i podružnica Distrikt Brčko.

Poslovni subjekti i dijelovi poslovnih subjekata dostavljaju podatke na osnovu knjigovodstvene evidencije, dok se za obrtničke klaonice podaci dobivaju od nadležnih općinskih službi (veterinarsko - inspekcijskih) na osnovu raspoložive evidencije.

### Definicije

**Bruto težina** jeste težina stoke i peradi prije klanja.

**Neto težina** jeste težina očišćenog trupa, zaklane stoke i peradi bez kože, krvi, glave (osim kod prasadi i peradi), utrobe, prednjih nogu do koljena i stražnjih nogu do skočnog zgloba.

**Randman** zaklane stoke i peradi predstavlja postotni odnos težine zaklane stoke i peradi (neto težine) i težine žive stoke i peradi (bruto težine), a iskazuje se u postocima s jednom decimalom.

### Notes on methodology

*The data on slaughter of livestock and poultry are result of agregation of comparable the data from monthly statistical surveys conducted Entity institutes for statistics and by the Bureau in Brcko District.*

*Data on legal entities and parts of legal entities are submitting data based on book-keeping, whereas for entrepreneurs avbattoirs data are given from approved municipal (veterinarian - inspection) department at the basis of available evidence.*

### Definition

**Gross weight** is the weight of livestock and poultry before slaughtering.

**Net weight** is the weight of dressed carcass of slaughtered animals without skin and blood, eviscerated and beheaded (excluding piglets and poultry), and after removal of fore ends and hind legs with knuckle.

**Coefficient of utilisation** of slaughtered livestock and poultry is a percentage ratio of the weight of the slaughtered cattle and poultry (net weight) and the weight of livestock and live poultry (gross weight), and it is presented in percentage calculated to one decimale place.
