BRUTO DOMAĆI PROIZVOD ZA BOSNU I HERCEGOVINU 2023. Rashodni pristup, prvi rezultati

*GROSS DOMESTIC PRODUCT OF BOSNIA AND HERZEGOVINA 2023
Expenditure approach, First results*

Agencija za statistiku BiH, u ovom priopćenju predstavlja preliminarne procjene Bruto domaćeg proizvoda (BDP) za 2023. godinu, procijenjenog rashodnim pristupom.

Ove godine se publicira serija podataka od 2019. do 2023.g., u tekućim cijenama, cijenama prethodne godine i serija podataka sa lančano povezanim vrijednostima, sa 2021. godinom kao referentnom godinom, te izračunani deflatori.

Serijski podaci koja se prezentiraju u ovom priopćenju se razlikuju od serije koja je publicirana ranije, zbog izmjena nastalih u podacima Centralne banke BiH.

Procjene su sačinjene prema metodologiji Europskog sustava računa 2010 (ESA 2010).


In this first release Agency for statistics of BiH, presents the preliminary estimates of Gross domestic product by the expenditure approach for 2023..

This year, data from the 2019 to 2023 at current and prices of the previous year have been published. The series of chain linked values, with the year 2021 as the reference year as well as the corresponding deflators have been published.

Data series presented in this release is different from the data series published earlier, due to changes in data obtained from Central Bank BH.

The estimates have been compiled according to the methodology of European System of Accounts 2010 (ESA 2010).

Comparative overview of expenditure categories of GDP, thousand KM, 2022 – 2023



Bruto domaći proizvod prema rashodnom pristupu, procijenjen je za 2023. godinu u iznosu od 50 932 milijuna KM, što predstavlja nominalni rast od 11,71%, odnosno promatrano u realnim vrijednostima predstavlja rast od 1,9%, u odnosu na 2022. godinu. Ovo ukazuje na rast cijena od 9,63%.

Izdaci za krajnju potrošnju kućanstava (66% BDP-a), iznosili su u 2023. godini 33 650 milijuna KM, što predstavlja nominalni rast od 10,79%. Promatrano u cijenama prethodne godine, nakon eliminiranja utjecaja rasta cijena, ukupna potrošnja je porasla za 1,02% u usporedbi sa prethodnom godinom.

Potrošnja kućanstava, raščlanjena prema namjeni, u nominalnim vrijednostima zabilježila je, nominalni rast u svim skupinama: Hrana i bezalkoholni napitci 13,61%, Alkoholna pića i duhan 6,3%, Odjeća i obuća 10,62%, Stanovanje 6,71%, Pokućstvo i održavanje stana 8,80%, Zdravstvo 13,09%, Transport 4,77%, Komunikacije 5,71%, Rekreacija i kultura 11,09%, Obrazovanje 13,03%, Restorani i hoteli 12,72%, te Ostala dobra i usluge 29,57%.

Najveći realan rast su ostvarile skupine:
Ostala dobra i usluge 12,03%, Zdravstvo 10,26%,
Rekreacija i kultura 4,78% i Odjeća i obuća 4,28%.

Izdaci za krajnju potrošnju vlade, (19% BDP-a) dostigli su iznos od 9 548 milijuna KM u 2023. što predstavlja porast od 12,15% promatrano u nominalnim vrijednostima i 2,12% promatrano u cijenama prethodne godine.

Bruto investicije u stalna sredstva, (22% BDP-a) su u 2023. dostigle nivo od 11 519 milijuna KM, što predstavlja nominalni rast od 14,26%, dok su u cijenama prethodne godine ostvarile rast od 12,06%.

Izvoz roba i usluga u 2023. u odnosu na 2022. bilježi i nominalni i realni pad u iznosu od 0,48% odnosno 1,25%.

Uvoz roba i usluga u 2023. u odnosu na 2022. zabilježio je nominalni pad od 1,55% i 1,28% promatrano u realnim vrijednostima.

Slijede tabelarni pregledi:

Gross domestic product by expenditure is estimated at 50 932 million of KM in 2023 and represent a nominal increase of 11,71% and 1,9% in real terms, from 2022 to 2023. These figures imply increase in prices of 9,63%.

Household final consumption expenditure (66% of GDP) reached amount of 33 650 million of KM in 2023, and represent nominal increase of 10,79%. At constant prices, after discounting the effect of price changes, consumption increased by 1,02% in comparison with previous year.

A breakdown of household consumption expenditure by purposes, recorded increase in nominal terms in all groups: Food and non-alcoholic beverages 13,61%, Alcoholic beverages and tobacco 6,3%, Clothing and footwear 10,62%, Housing 6,71%, Furnishing and routine households maintenance 8,80%, Health 13,09%, Transport 4,77%, Communication 5,71 %, Recreation and culture 11,09%, Education 13,03%, Restaurants and hotels 12,72% and Miscellaneous goods and services 29,57%.

The significant real increase was recorded in the groups: Miscellaneous goods and services 12,03%, Health 10,26%, Recreation and culture 4,78% and Clothing and footwear 4,28%.

General government consumption expenditure (19% of GDP) reached amount of 9 548 million of KM in 2023 and represents increase of 12,15% in nominal terms and 2,12% in real terms.

Gross fixed capital formation (22% of GDP) has reached the amount of 11 519 million of KM in 2022 and represents increase of 14,26% in nominal terms and 12,06% in real terms.

Export of goods and services in 2023 in comparison to 2022 registered nominal decrease by 0,48% and real decrease by 1,25% respectively.

Import of goods and services in 2023 in comparison to 2022 registered decrease by 1,55% nominally and by 1,28% in real terms.

METODOLOŠKA POJAŠNjenja:

Bruto domaći proizvod (BDP) prema rashodnom pristupu definira se kao ukupna domaća krajnja potrošnja korigirana vanjskom bilancom roba i usluga sa ostatkom svijeta. Temeljne komponente su:

- Izdaci za krajnju potrošnju kućanstava,
- Izdaci za krajnju potrošnju neprofitnih institucija koje usluge pružaju kućanstvima,
- Izdaci za krajnju potrošnju vlade,
- Bruto investicije,
- Izvoz i uvoz roba i usluga.

Izdaci za krajnju potrošnju kućanstava sastoje se od izdataka rezidentnih kućanstava na potrošnju roba i usluga za direktno zadovoljenje ljudskih potreba i želja.

Izdaci za krajnju potrošnju neprofitnih institucija koje usluge pružaju kućanstvima se sastoje od roba i usluga koje neprofitne institucije pružaju kućanstvima bez naknade ili u cijenama koje nisu ekonomski značajne.

Izdaci za krajnju potrošnju vlade obuhvaćaju dvije kategorije izdataka: Izdatke za individualnu potrošnju i Izdatke za kolektivnu potrošnju. Izdaci za individualnu potrošnju vlade sastoje se od isplata za netržišne usluge vlade (obrazovanje, zdravlje, socijalnu pomoć, kulturu, sport itd.) i izdataka za tržišne proizvode i usluge (lijekove, ortopedska pomagala, usluge lječilišta itd.) direktno dostavljenih kućanstvima, kao socijalni transfer u naturi. Izdaci za kolektivnu potrošnju vlade uglavnom se sastoje od izdataka za administrativne, obrambene, ekonomske, razvojno istraživačke i druge netržišne usluge vlade.

Bruto investicije se sastoje od bruto investicija u stalna sredstva, promjena na zalihamu i neto stjecanja dragocjenosti. Bruto investicije u stalna sredstva sastoje se od investicija u nova stalna sredstva, troškova transakcija za postojeća stalna sredstva i nabavke ne proizvedene aktive. Promjene zaliha odnose se na zalihe proizvodnje u tijeku, zalihe gotovih proizvoda, zalihe trgovačke robe i zalihe sirovina i materijala.

Podaci o **izvozu i uvozu roba i usluga** temelje se na bilanci plaćanja Centralne banke Bosne i Hercegovine. Vrijednost izvezene robe obračunava se po paritetu fob, a vrijednost uvezene robe po paritetu cif.

NOTES ON METHODOLOGY:

Gross domestic product (GDP) by the expenditure approach is defined as a total domestic final consumption corrected by the external trade balance with the rest of the world. The main components are:

- Household final consumption expenditure,
- Final consumption of non-profit institutions serving households,
- Final consumption of general government,
- Gross capital formation,
- Export and import of goods and services.

Household final consumption expenditure consists of the expenditure incurred by resident households on the consumption goods and services for the direct satisfaction of human needs and wants.

Final consumption expenditure of non-profit institutions serving households consists of the goods and services which non-profit institutions provide to the households free or at the prices that are not economically significant.

Final consumption of general government includes two categories of expenditure: Individual government consumption expenditure and Collective government consumption expenditure. Individual government consumption expenditure comprises payment for the non-market government services (education, health, social care, culture, sport, etc.) and the market goods and services (pharmaceutical and therapeutic products, health resort services) supplied directly to the households as a social transfer in kind. Collective government consumption expenditure consists of the expenditure on the administrative, defence, economic, R&D and other non-market government services.

Gross capital formation is composed of a gross fixed capital formation, changes in stocks and acquisition less disposals of valuables. Gross fixed capital formation consists of the investments into the new fixed capital formation, costs of transactions of existing fixed assets and additions to the value of non-produced assets. Changes in stocks refer to the changes of work-in-progress, changes of finished goods, changes of goods in stores and of raw material.

Import and export of goods and services are based on the balance of payments data taken over from Central bank of Bosnia and Herzegovina. The export value of goods is calculated by fob, while import value of goods is calculated by cif parity.
