MJESEČNI INDEKSI INDUSTRIJSKE PROIZVODNJE ZA BOSNU I HERCEGOVINU FEBRUAR 2024 – FEBRUAR 2025 MONTHLY INDICES OF INDUSTRIAL PRODUCTION FOR BOSNIA AND HERZEGOVINA FEBRUARY 2024- FEBRUARY 2025

Agencija za statistiku BiH, pored redovnog mjesečnog saopćenja o indeksu fizičkog obima industrijske proizvodnje, počela je redovno objavljivanje serije mjesečnih indeksa koji obuhvataju trinaest posljednjih mjeseci obračunatih prema baznoj, 2021. godini.

Rezultati indeksa industrijske proizvodnje prikazuju se u četiri oblika:

- Izvorni indeksi obima industrijske proizvodnje
- Desezonirani indeksi obima industrijske proizvodnje
- Kalendarski prilagođeni indeksi obima industrijske proizvodnje
- Trend serija indeksa obima industrijske proizvodnje

Prikazane serije obuhvataju izvještajni mjesec tekuće godine i dvanest mjeseci koji mu prethode, uvijek uključujući isti mjesec prethodne godine.

Agency for Statistics of BiH, next to regular monthly release on the volume index of industrial production, started with the regular publication of monthly series covering the last thirteen months calculated according to the base, 2021 year.

Results of the indices of industrial production are presented in four forms:

- Gross indices of industrial production
- Seasonally adjusted indices of industrial production
- Working-day adjusted indices of industrial production
- Trend series of industrial production indices

Presented series include the reporting month of the current year and the twelve months preceding it, always including the same month last year.

METODOLOŠKA OBJAŠNENJA

Agencija za statistiku BiH i entitetski zavodi za statistiku su uskladili prezentaciju i interpretaciju mjesečnih indeksa industrijske proizvodnje s onom koja je propisana EU uredbama o kratkoročnim poslovnim statistikama i preporukama Eurostata o publikovanju indeksa industrijske proizvodnje. Agencija za statistiku BiH, pored redovnog mjesečnog saopćenja o indeksu fizičkog obima industrijske proizvodnje, redovno objavljuje i serije mjesečnih indeksa koji su obračunati prema baznoj 2021. godini.

Usklađivanje sa statističkim konceptima EU i način prezentacije podataka omogućuje korisnicima podataka neposredno poređenje podataka za Bosnu i Hercegovinu sa podacima drugih zemalja koje prezentuje i publikuje Eurostat na internet stranicama: <http://ec.europa.eu/eurostat> i <http://ec.europa.eu/eurostat/euroindicators>

Metod računanja

Koncepti, definicije i metodologija koji se koriste za izračunavanje indeksa industrijske proizvodnje su usklađeni sa EU propisima u domenu kratkoročnih statistika (*EU STS - Short Term Statistics*).

Osnovne informacije o indeksu industrijske proizvodnje i kratka metodologija izračuna prikazane su u dokumentu "Metodološka uputstva za izračunavanje indeksa fizičkog obima industrijske proizvodnje u Bosni i Hercegovini - (MD 29)" koja je dostupna na web stranici Agencije za statistiku BiH: <http://www.bhas.gov.ba> u sekciji industrija.

Standardi i klasifikacije

Za izračunavanje i objavljivanje rezultata indeksa industrijske proizvodnje od 2013. koriste se novi standardi: BiH klasifikacija djelatnosti - KD BiH 2010 (EU NACE Rev.2.) i Mjesečna NIP BiH 2024. Mjesečna NIP BiH 2024 je Nomenklatura industrijskih proizvoda Bosne i Hercegovine, koja se koristi za provođenje Mjesečnog izvještaja industrije M KPS IND-1. Mjesečna NIP BiH 2024 zasnovana je na izvornoj NIP BiH 2010 (Službeni glasnik br. 12/11 i 41/11) i ažurirana sa izmjenama i dopunama u EU PRODCOM Listi nastalim od 2013. godine. Mjesečna NIP BiH 2024 je dodatno razrađena i dopunjena u skladu sa specifičnim potrebama obračuna indeksa industrijske proizvodnje u BiH, a saglasno sa EU regulativama za kratkoročne poslovne statistike.

NOTES ON METHODOLOGY

Agency for Statistics of BiH and Entity Statistics are harmonized presentation and interpretation of monthly industrial production indices with those arranged by the EU regulations on short-term statistics and Eurostat's recommendations on publication of the industrial production indices. Agency for Statistics of BiH, next to regular monthly releases on the index of industrial production, regularly publishes series of monthly indices which are calculated according to the base 2021 year.

Harmonization with the EU statistical concepts and method of presentation of data enables users of data to directly compare data for Bosnia and Herzegovina with the data of other countries which are published on the Eurostat website: <http://ec.europa.eu/eurostat> and <http://ec.europa.eu/eurostat/euroindicators>.

Calculation method

Concepts, definitions and methodology used for calculating of the industrial production indices are harmonized with the EU Regulations in the field of Short Term Statistics (*EU STS*).

The basic information on BiH industrial production index and short methodology are presented in the publication "Methodological guidelines for the calculation of the industrial production index in Bosnia and Herzegovina (MD 29)", which is available on the website of the Agency for Statistics of BiH: <http://www.bhas.ba> in Industry section.

Standards and Classifications

For calculating and publishing the results of the industrial production index from 2013, new standards are used: BiH Classification of Activities KD BIH 2010 (EU NACE Rev. 2.) and Monthly Nomenclature of Industrial Products NIP BiH 2024. Monthly NIP 2024 Nomenclature of Industrial Products of Bosnia and Herzegovina, which was used for the implementation of Monthly Industry Report M KPS IND-1. Monthly NIP 2024 is based on the original NIP BiH 2010 (Official Gazette no. 12/11 and 41/11) and updated with amendments in EU PRODCOM Lists occurring since 2013. Monthly NIP 2024 is further developed and supplemented in accordance with the specific purpose of calculating the index of industrial production in BiH, and in accordance with EU regulations for short-term business statistics.

Indeks industrijske proizvodnje (IPI) obuhvata djelatnosti koje su razvrstane u sljedeća područja KD BiH 2010:

- B - Vađenje ruda i kamena
- C - Prerađivačka industrija
- D - Proizvodnja i snabdijevanje električnom energijom i plinom (isključujući granu 35.3)

Saglasno EU STS propisu Oblast 36 - Sakupljanje, prečišćavanje i snabdjevanje vodom i Grana 35.3 - Proizvodnja i snabdijevanje parom i klimatizacija ne ulaze u obračun indeksa industrijske proizvodnje.

Izvod iz KD BiH 2010 koji se odnosi na područja i oblasti djelatnosti koji pripadaju industriji nalazi se u sastavu saopćenja.

Agregati glavnih industrijskih grupa (GIG)

Grupisanje se vrši prema pretežnoj upotrebi proizvoda unutar oblasti i grane djelatnosti iz klasifikacije KD BiH 2010.

- **AI - Proizvodi za međufaznu potrošnju:** oblasti i grane KD BiH 2010: 07 – 09, 10.6, 10.9, 13.1 – 13.3, 16, 17, 20.1 – 20.3, 20.5, 20.6, 22 – 24, 25.5 – 25.7, 25.9, 26.1, 26.8, 27.1 – 27.4 i 27.9
- **AE - Energija:** oblasti KD BiH 2010: 05, 06, 19 i 35 (isključujući 35.3)
- **BB - Kapitalni proizvodi:** oblasti i grane KD BiH 2010: 25.1 – 25.4, 26.2, 26.3, 26.5, 26.6, 28, 29, 30.1 – 30.4, 32.5 i 33
- **CD - Trajni proizvodi za široku potrošnju:** oblasti i grane KD BiH 2010: 26.4, 26.7, 27.5, 30.9, 31, 32.1 i 32.2
- **CN - Netrajni proizvodi za široku potrošnju:** oblasti i grane KD BiH 2010: 10.1 – 10.5, 10.7, 10.8, 11, 12, 13.9, 14, 15, 18, 20.4, 21, 32.3, 32.4 i 32.9

Prikazivanje serija indeksa

U skladu sa preporukama Eurostata, desezoniranje i kalendarsko prilagođavanje se vrši metodom TRAMO-SEATS u JDEMETRA+ okruženju na mjesečnoj seriji izvornih indeksa industrijske proizvodnje. Produžavanje serije indeksa dodavanjem novih mjesečnih zapazanja za svaki idući mjesec može, zbog karakteristika primijenjene metode, prouzrokovati ispravke već objavljenih desezoniranih i kalendarski prilagođenih indeksa za nekoliko mjeseci unazad.

Industrial production index (IPI) covers activities classified into the following sections of the KD BiH 2010:

- *B - Mining and quarrying*
- *C - Manufacturing*
- *D - Electricity and gas supply (excluding group 35.3)*

In line with EU STS Regulation Section 36 - Collection, purification and water supply and Group 35.3 - Production and supply of steam and air conditioning are not included in the calculation of the index of industrial production.

Main Industrial Grouping (MIGs) aggregates

Grouping is done according to the prevailing use of the product within the division and group of NACE rev.2.

- **BB - Capital goods:** the KD BiH 2010 divisions and groups: 25.1 – 25.4, 26.2, 26.3, 26.5, 26.6, 28, 29, 30.1 – 30.4, 32.5 and 33
- **CD - Consumer durables:** the KD BiH 2010 divisions and groups: 26.4, 26.7, 27.5, 30.9, 31, 32.1 and 32.2
- **CN - Consumer non-durables:** the KD BiH 2010 divisions and groups: 10.1 – 10.5, 10.7, 10.8, 11, 12, 13.9, 14, 15, 18, 20.4, 21, 32.3, 32.4 and 32.9

Indices series presentation

In accordance with the Eurostat's Recommendations, seasonal adjustment and working-day adjustment has been done by using the TRAMO-SEATS method in JDEMETRA+ environment on the monthly series of original industrial production indices. Extending indices series by adding new monthly observations for each month could, because of the applied method characteristics, cause subsequent corrections of already published seasonally and working-day adjusted indices for several months backwards.
