#### KLANJE STOKE I PERADI U KLAONICAMA, 2025

#### SLAUGHTERING OF LIVESTOCK AND POULTRY IN SLAUGHTERHOUSES, 2025

U tijeku 2025. godine povećan je broj zaklanih goveda za 20,13%, svinja za 15,71% i peradi za 3,00%, dok je broj zaklanih ovaca smanjen za 4,07% u usporedbi s razdobljem 2024. godine.

During the 2025 year the number of slaughtered cattle increased by 20,13%, of pigs by 15,71% and of poultry by 3,00%, while the number of slaughtered sheep decreased by 4,07% in relation with the period of 2024.

Neto težina zaklanih goveda je povećana za 22,71%, svinja za 22,95% i peradi za 3,94%, dok je neto težina zaklanih ovaca smanjena za 9,53% u usporedbi s razdobljem 2024. godine.

The net weight of slaughtered cattle increased by 22,71%, of slaughtered pigs by 22,95% and of slaughtered poultry by 3,94%, while the net weight of slaughtered sheep decreased by 9,53% in relation with the period of 2024.

### Metodološka objašnjenja

Podaci o klanju stoke i peradi dobiveni su agregiranjem podataka na osnovu usporedivih mjesečnih statističkih istraživanja koja provode entitetski zavodi za statistiku i podružnica Distrikt Brčko.

Poslovni subjekti i dijelovi poslovnih subjekata dostavljaju podatke na osnovu knjigovodstvene evidencije, dok se za obrtničke klaonice podaci dobivaju od nadležnih općinskih službi (veterinarsko - inspekcijskih) na osnovu raspoložive evidencije.

### Definicije

**Bruto težina** jeste težina stoke i peradi prije klanja.

**Neto težina** jeste težina očišćenog trupa, zaklane stoke i peradi bez kože, krvi, glave (osim kod odojaka i peradi), utrobe, prednjih nogu do koljena i stražnjih nogu do skočnog zgloba.

**Randman** zaklane stoke i peradi predstavlja postotni odnos težine zaklane stoke i peradi (neto težine) i težine žive stoke i peradi (bruto težine), a iskazuje se u postocima s jednom decimalom.

### Notes on methodology

*The data on slaughter of livestock and poultry are result of agregation of comparable the data from monthly statistical surveys conducted Entity institutes for statistics and by the Bureau in Brcko District.*

*Data on legal entities and parts of legal entities are submitting data based on book-keeping, whereas for entrepreneurs avbattoirs data are given from approved municipal (veterinarian - inspection) depeartment at the basis of available evidence.*

### Definition

**Gross weight** is the weight of livestock and poultry before slaughtering.

**Net weight** is the weight of dressed carcass of slaughtered animals without skin and blood, eviscerated and beheaded (excluding piglets and poultry), and after removal of fore ends and hind legs with knuckle.

**Coefficient of utilisation** of slaughtered livestock and poultry is a persentage ratio of the weight of the slaughtered cattle and poultry (net weight) and the weight of livestock and live poultry (gross weight), and it is presented in percentage caltulated to one decimale place.
